### B) CENTRE FOR DISABLED (TREATMENT & REHABILITATION) :

Institution started Centre for Disabled (Treatment & Rehabilitation) at Ayodhya General Hospital. The project is sponsored by Department of Empowerment of Person with Disabilities, Ministry of Social Justice & Empowerment, Govt. of India, New Delhi. We provide services to all type of Disabled population like Hearing Impairment, Vision Impairment, Physically Handicapped, Locomotors Impairment & Mentally retarded. We conduct Free Disabilities Detection Camps for detection of the disabilities and provide them Aids/appliances as per their needs. After fitting of aids/appliances we give them proper training to the patients and their parents 'How to Use' the aids / appliances and plan for their rehabilitation. We also are doing surgical correction to overcome the disabilities. During the year 2016-2017 we have given benefits for 2010 Disabled patients through our Centre.

## **D) COMMUNITY BASED REHABILITATION through RURAL HEALTH PROGRAMME - in Purandar Tehsil, Dist. Pune**

Ministry of Finance, Govt. of India, extend & sanction special project to our institute for three years – 2015-16 to 2017-18 under 35 AC of Income Tax name as "**Community Based Rehabilitation through Rural Health Programme**".

The project has been divided in three parts which is as follows:

1. Rural Health Services
2. Services to Disabled persons specially for Hearing Impairment
3. In Door facilities for Rural & Urban population at Ayodhya General Hospital, Wanwadi, Pune

### **1. Rural Health Services :**

Institution adopted 20 villages from Purandar Tehsil. We provide O.P.D. services in all villages. The team of Medical & Para-medical staff provides services in above villages. While giving the O.P.D. services if they found any emergency they will shift to the patients at our Hospital, Wanwadi and give further treatment.

We also conduct the free Disability detection camp at Purandar Tehsil and cover all block - 116 villages and 2 cities. During the year we have provided our services to -

## **2. Services to Disabled especially to Hearing Impairment :**

Institution started Residential School for Deaf & Research Centre and Centre for Disabled at Wanwadi. We have adopted 75 Hearing Impaired children where all facilities including Education, Lodging & Boarding provide free of cost. We provide services to H.I. children like –

- Free Special Education
- Free Lodging & Boarding facilities
- Personality development activities

## **3. In-door services at Ayodhya General Hospital :**

Institution provides Indoor facilities to poor population to those can't afford the expenses of hospital. We provide these services in very concessional charges to Zilla Parishad & Municipal Corporation Schools. We have also provided our services to children with special needs under Sarva Shiksha Abhiyan. During the year we have done surgical corrections of **132 persons Free of Cost.**

## **E) SARVA SHIKSHA ABHIYAN PROGRAMME :**

Government of India started Sarva Shiksha Abhiyan Project in 2000-01. The **Universalization of the Elementary Education** is the basic aim of this project. Education for children with Special needs is one of the important Objective in S.S.A. children with special needs will be supported by Government in all the way.

Our Institute is supporting to Government of Maharashtra by contributing different activities these are.

### **1) SRG / DRG Membership:**

The Director of trust is member of SRG M.P.S.P., Govt. of M.H., Mumbai & DRG (District Resource Group) Pune

### **2) Foundation Course on Education of Children with Disability:**

Rehabilitation Council of India – New Delhi and Indira Gandhi National Open University – New Delhi conducts Foundation Course of 90 days. We have not trained Normal teachers from various districts during the academic year 2016-17.

### **3) SUPPORTIVE SERVICES TO SCERT:**

Staff of our institute supported to SCERT Pune to implement various programmes and to develop the material on various subjects. We have also supported to preparation of Handbooks for Political Representative, Handbook for trainers and hand books for General educators.

### **4) EXPERT SERVICES FOR ASSESSMENT OF HEARING LOSS AND PROVIDE NEED BASE SERVICES :-**

The Expert Medical & Para-medical & Professional team of our institute helps to MPSP and various Education Department Zilla Parishad & Municipal Corporations to detection of hearing loss of Hearing Impaired children.

During the year 2016-17 we have not organized and participated in camps and other activities.

## **F) REHABILITATION COUNCIL OF INDIA PROGRAMME:**

The Need For Special Educators/professionals In The Field Of Disability Rehabilitation And Special Education.

The Government of India's flagship programme Sarva Shiksha Abhiyan (SSA), which is the core of Right to Education Act, lays special emphasis on providing education to 'children with special needs'.



SSA has been harmonized with the RTE Act. A landmark judgment by the Hon'ble Delhi High Court has resulted in increased demand for trained special teachers to be appointed two in each school of NCT of Delhi. Similar demand is expected to be created in other States and UTs with National Council for Teacher Education (NCTE) granting approval to B.Ed. (SE) and D.Ed. (SE) qualifications for appointment of elementary teachers in general schools. Chances of securing a job in Govt. departments, medical and paramedical services, NGOs, in public as well as private sectors are bright.

## **College of Special Education:**

Our Trust is running College of Special Education since 1999-2000 for creating / developing manpower in the field of Special Education. Under college of Special Education various activities have been undertaken through different programmes. The details are as follows:

### **A) REGULAR MODE COURSES:**

#### **1) B.Ed. SE (H.I) Bachelor of Education Speical Education (Hearing**

**Impairment ):** Our institution is offering B.Ed SE (Hearing Impaired) 2 years course recognized with Rehabilitation Council of India and affiliated with SavitribaiPhule Pune University, Pune. The curriculum has been developed to Empower the Special teachers / educators to ensure education of students with disabilities in an inclusive, right based and barrier free environment. The prime intention is to develop a task force of the home based and in all the roles: classroom teacher, resource teacher, itinerant teacher or cross disability teacher facilitators. The program duration of two years so that a wide range of knowledge and skills can be inculcated in trainee teacher during the program. Difference in philosophies and theories between Special and General Education need to be bridge and special educators and teachers trained to collaborate to meet diverse needs in the classrooms.

The Bachelor of Education programme B.Ed. Special Education (H.I) is a professional course that prepare teachers for Upper Primary (Class VI – VIII), Secondary level (Class IX – X) and Higher secondary level (Classes XI – XII) for special and inclusive school.

#### **Objectives of the Course:**

The B.Ed. Special Education programme aims to develop teachers for children with disabilities for various settings (including inclusive, Special, Open school and Home based Education). The B.Ed Special Education (Hearing Impaired) course will prepare human resource to enable them to acquire knowledge and develop competencies and skills to impart education and training effectively to all children including children with Special Needs. After completing B.Ed. Special Education (H.I) programme the student's teachers will.

1. Acquire knowledge and skills about human development contemporary Indian Education and pedagogy of various school subjects and assessment of learning.
2. Acquire knowledge and skills about nature and educational needs of children with specific disabilities.
3. Develop conceptual understanding of education provisions and skills for working with children with various disabilities in special and inclusive settings.
4. Enhance knowledge and skills of professional development.

#### **Eligibility for Admission:**

A candidate should have passed the Bachelor's Degree / Master degree in Science, Social sciences / Humanities / Commerce of SavitribaiPhule Pune University or of any other recognized university with at least 50% marks or Bachelor in Engineering / Technology / Agriculture with specialization in Science and Mathematics of any recognized University with atleast 55% marks.

The reservation and relaxation of 5% marks will be given to the candidates belonging to SC/ST/VJNT/OBC/PWD and other notified categories as per the Maharashtra State Govt.



**Admission procedure:**

Admission to the eligible candidates shall be made on merit or the basis of marks obtained in the qualifying examination and / or in the entrance examination or as per the selection procedure lay down by the Higher Education, Govt. of Maharashtra and PraveshNiyantranSamiti.

**Medium of instruction:**

Medium of instruction at the B.Ed.S.E.(H.I.) course will be Marathi or English or Hindi.

**Intake capacity:**

25 candidates per year.

**Duration of Course :** The duration of course will be two years

**General Frame work of the course:**

The B.Ed. Special Education (H.I) is two years degree programme consist of—

- 1) Five core papers
- 2) 6 Cross disability and inclusive Education courses
- 3) 5 disability specialization courses
- 4) 3 Professional development courses.

All together 19 theory paper and 4 different practical area. E<sub>1</sub>, E<sub>2</sub>, D<sub>1</sub> and D<sub>2</sub>.

**Extra Curricular activities:**

The students of B.Ed. Special Education (H.I) have actively participated and organized the different activities

- 1) 5<sup>th</sup> September – Teacher's Day celebration
- 2) 28<sup>th</sup> September – International Deaf Day
- 3) 2<sup>nd</sup> October - Gandhi Jayanti
- 4) 3<sup>rd</sup> December – World Disability Day

**Assessment and Evaluation system:**

Continuous Internal Assessment was carried out during the academic session. The trainees have to undergo through Pre-midterm, midterm and preliminary examinations as well as classroom presentation. The final theory examination will be held from 28<sup>th</sup> May 2017 to 1<sup>st</sup> June 2017. The results of B.Ed. (H.I) students will declaration in July 2017.

## **2) Diploma in Education – Special Education –Hearing Impairment [D.Ed. SE (HI)]:**

Diploma in Special Education is the first Man Power Development program started in 1999 at Ayodhya Charitable Trust Pune. **Rehabilitation Council of India (RCI)** has recognized and approved our institute to run the D.Ed.SE (HI), 2 years full time course with 4 semester pattern. Examination for this course is conducted by the examining body 'AliYavar Jung National Institute of Speech & Hearing Disabilities (Divyangjan), Mumbai' nominated for this purpose by RCI.



**Aim & Objectives:**

Aim and Objectives are set with special reference to children with hearing impairment. The main aim is to develop professionals for special education within a broad framework of education in the current millennium. The general objective of the course is to prepare special teachers at pre-Primary (Nursery, Kindergarten etc.) and primary (I to IV – lower primary and V to VII – upper primary) levels to serve in the following settings:

- i) Special schools
- ii) Integrated \ Inclusive setup
- iii) Itinerant programs

**Eligibility criteria:** 10 + 2 or its equivalent examination passed with minimum 50% Marks and 45% marks or as per state govt. rule for SC, ST, OBC and PWD.

**Duration of the course:** The duration of the course will be **two years** (four semesters) (220 days consisting of 1320 hrs. each year, thus having a total of 440 days consisting of 2640 hours for theory and practicum)

**Medium of Instruction:** The medium of instruction will be **English / Hindi / Marathi** (Regional language)

**Minimum Attendance:** minimum 80% attendance was required both in theory and practical to be eligible to appear in the semester end examination.

**Intake capacity:** Maximum 25 candidates per academic year.

**Admission procedure:** Direct Admission - on submission of prescribed application form given by R.C.I with related documents. Admission procedure started from May 2016. The detail of students are -

First year 2016-18 batch : 14 students

Second year 2015-17 batch : 12 students

Took admission for D.Ed SE (H.I) at our institute for academic year 2016-17.

**Special features of the course are:**

**I) Theory Course:** The D.Ed.SE (HI) course consists of total 12 theory papers distributed in 4 core papers, 6 papers pertaining to specific disability areas and 2 School Subjects (Content Cum Methodology). Each paper will have a total of 90 hours for curriculum transactions per the following scheme:

**1<sup>st</sup> year**

Sem I: 1 core Papers & 3 disability specific paper

Sem II: 1 core Papers & 1 disability specific paper

**2<sup>nd</sup> year**

Sem III: 1 core Papers, 1 disability specific paper & 2 School Subjects (Content Cum Methodology)

Sem IV: 1 core Papers & 1 disability specific paper

**Methodology:** Generally Lectures, demonstration, discussions, & Project method is used to complete the theory course successfully with effective use of audio-visual aids i.e. OHP, LCD projector, C.D. player etc. We also arrange various subject experts as for Guest Lectures.

## **II) Practical course:**

Students got practical exposure of –

- Classroom observations & lesson Demonstration
- Practice teaching in Special (H.I.) School & Inclusive schools
- Full time teaching Practice in Special (H.I.) School
- Visit to Rehabilitation Institutes: In practical course, students are provided complete exposure to the various disabilities related problems through visit to various rehabilitation schools & institutes
- Content test (text books from I std to VII std.)
- Individualized teaching lesson (IEP)

### **3) Diploma in Hearing Language & Speech (D.H.L.S.):**

Rehabilitation Council of India has recognized the Diploma in Hearing, Language & Speech program to our institute in academic year 2002-2003. It is recognized by R.C.I. New Delhi & A.Y.J.N.I.S.H.D. (D)., Mumbai. This is a one year practical oriented program.

**Aim:** Aim of the programme is to train personnel and equip them with the basic skills for providing speech language therapy, for conducting programs for early identification of persons with communication disorders, educating people on prevention of communication disorders.

**a) Duration of the course:** The duration of the course is **one year**, which can be completed in a maximum of two years from the date of admission to the program.

#### **Eligibility criteria:**

- 1) Pass in 12<sup>th</sup> Science with Physics, Chemistry, Biology and Mathematics/ computer science.
- 1) Minimum 50% marks for OPEN and 45% marks for OBC/SC/ST candidates is required
- 2) Candidates age should be <21 years on 1<sup>st</sup> July of the year of admission.

They also have to attend final Speech and Audiology Oral Viva.

The successful candidates who pass in theory and practical examination will be awarded the diploma / certificate by the examining body nominated for this purpose by the **Rehabilitation Council of India (RCI)**.

f) **Scope of the course:**

They can work as a Speech and Hearing technician or Assistant Speech Therapist in different set-up like Govt. Set up, Semi-govt. set up, private set up under the guidance of a fully trained graduate or postgraduate Speech and Hearing clinician, in the present scenario there is a **great demand for speech and hearing professionals in these various set ups.**

### **Assessment of Hearing Loss:**

All students assess by our Chief E.N.T. surgeon and Audiologist and Speech Therapist. After having their recommendation, we admit the students in school. All students were also assessed by Medical Superintendent - Sassoon General Hospital - Pune and Civil Surgeon Aundh Hospital Pune and they issued the Disability Certificate.

### **Aids & Appliances:**

After the assessment of Hearing loss and recommendation by Audiologist we provide them individual Behind the Ear (B.T.E.) Hearing Aids to all the students according to their Hearing loss. We provide them Binaural Hearing Aids to all students except 2 to 3 students. All Hearing Aids is received from ServaShikshaAbhiyan - Starkey Foundation and our Parent organization and Nihlent Technologies Ltd. Pune

### **Equipments:**

#### **A) BERA, Impedance Audiometers :**

**B) Group Hearing Aids:** We have purchased 3 Group Hearing Aids system of 8 students for improvement of the Hearing capacity of student. We have 3 Group Hearing Aids at our school during 2016-17.

**C) Loop Induction System:** We have made arrangement of Loop Induction System in one class. This is new thing institution started as a Research part and for std I class.

**D) Computerized Speech Therapy Programme:** British High Council has donated Computerized Speech Therapy Programme i.e. "Dr. Speech". With the help of Dr. Speech our Speech Therapist develops the speech & language. We have developed various Software in Marathi language for improvement of language of each deaf child. Each Deaf student undergoes the training of Dr. Speech simultaneously. With the results we had develop the Speech of language of children

**E) Speech Trainer:** Institution has 7 Speech Trainer with mirror to improve the Speech & language of deaf student. The Special Teacher teaches each student with the help of Speech Trainer in front of mirror. We have given 5 speech trainers in all pre-primary class rooms.

**F) Sound Proof Room:** Institution prepared/designed ideal two room set-up Sound Proof Room. We have applied the latest technology while preparing the room. This is a unique room prepared for the correct assessment of Hearing Loss. We have inserted/fitted talk back system in Sound Proof Room.

**G) Audiometers:** Institution has 5 Audiometer for Assessment of hearing loss. We perform 14 types of various tests on the Audiometers and another has a Portable Audiometer, Screening audiometer, infantile audiometer etc.

**H) Speech Therapy Rooms:** Institution has 6 Speech Therapy rooms. In this room individual speech training is given to develop their speech.

**I) Sound Level Meters:** Institution has three Sound Level Meters for Assessment of Noise level in various places. We have Portable (Hand) Sound level Meter, Octave Band Analyzers Sound Level Meter and 2231 Computerized Sound Level Meter which will continuously collected data on 31 hours.

**J) Ear Mould Lab:** Institution started Ear Mould Lab with all equipments and all accessories. All type of ear mould prepared in our School for better communication between two persons. We prepared Pocket Model, BTE & ITC Ear Mould.

**K) Hearing Aid repairing room:** Institution has four sets of Hearing Aids repair and servicing with qualified technician. Institution has 10-bedded well-equipped hospitals in premises of institution. E.N.T Depart. is one of major department in hospital which give the services to the Hearing Impaired population.



- L) B.T.E. Hearing Aid:** All students are given B.T.E. Hearing Aid by SarvaShikshaAbhiyan, Starky Foundation and our Parent organization. 51 BTE Hearing Aids Starkey
- M) Teaching Learning Material:** We have developed & purchased the teaching learning material for the school, which develops the language of deaf child. T.L.M. is very important task in Educational Programme of the Hearing Impaired School.
- N) E-learning programme:** All students are given exposure through taught by e-learning programme methods which is easier for children of Hearing Impaired children.
- O) Sport Equipment:** We have purchased the sport equipments for the development of physical aspects of the deaf children.
- P) Computer room:** Our school has a Computer Lab with 5 Computer along with Printer. Our Special Educators gives special inputs to learn Computer b) Hearing impaired students.
